Jubilee Highland Hills is committed to the goal of providing a quality education for every student in this school. An essential component in ensuring that students are successful in school is parental engagement. We believe that when parents are involved and engaged in the academic process, school becomes a priority and their children become lifelong learners. We pledge to maintain a line of **open communication** from school to home and provide many opportunities for parental involvement throughout the school year.

A. Annual Title 1 Meetings

Jubilee Highland Hills will hold an annual fall meeting each school year to review with parents the Title I Program, McKinney-Vento Act, School-Parent Compact, and Parent & Family Engagement Policy. This meeting, held at a convenient time, is to inform parents of their school's participation and explain the rights of parents/families to be engaged. It is an opportunity for parents, teachers and community members to get an overview of the school and discover the school's mission and vision. Jubilee Highland Hills will also provide information for 8th grade students regarding a high school graduation plan, Advanced Placement (AP) and dual enrollment classes. There will also be a "8th Grade Transition to High School" meeting held during the first semester.

Information related to the school and parent programs, meetings, and other activities, will be sent to the parents of participating students in an understandable and practical and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents can understand.

E. Survey

An annual survey will also be available to parents for any suggestions, ideas, and requests. All will be taken into consideration and followed up in a timely manner.

F. School-Parent Compact

Jubilee Highland Hills will jointly develop with the parents, a school-parent compact that outlines how families, school, staff and students will share responsibility for improved student academic achievement, school attendance and behavior and develop a partnership to help children achieve the state's high standard and how the plan is used, reviewed and updated.
